**New Prosecutorial Performance Indicators to be Released**

*In the wake of widespread calls for criminal justice reforms, new indicators are designed to redefine success in prosecution.*

On Thursday, October 1, Florida International University and Loyola University at Chicago, with support from the John D. and Catherine T. MacArthur Foundation's *Safety & Justice Challenge*, will unveil new Prosecutorial Performance Indicators. These indicators redefine what success looks like in the field of prosecution. In conjunction with this release, the project's team and [Fair and Just Prosecution](#) will hold a press briefing with reform-minded elected prosecutors who have been involved in this initiative from its inception three years ago. These leaders have partnered with researchers to develop and use these new metrics to advance change in practice and culture in their offices that promotes just results. Given the widespread calls for a new vision for public safety and transformation of the broader criminal justice system, this will be a timely conversation and an opportunity to better understand:

- Why it is necessary to go beyond traditional measurements of success in prosecution, which have historically been premised on metrics such as conviction rates and sentences.
- What the new performance indicators are and how they better serve prosecutors' offices and their communities.
- How the new indicators help to create greater transparency, accountability and, ultimately, fairness in the criminal justice system.

**WHAT:** Release of new Prosecutorial Performance Indicators. The briefing will include an overview of the indicators followed by a Q&A with the research team and the four prosecutors who have been participants in the project.
